7. Other matters: Chien Nan Lee proposed to hold FAOPS Congress every year to maintain active participation among member countries.

Comments: Number of active member countries to potentially host annual congress not many (David) Cost and extent of work needed for congress might be prohibitive for some countries. Everyone agreed that 3 regional perinatal workshops in between the biannual congress would be best for the moment as we continue to try and encourage participation of member countries. These workshops shall continue to be facilitated by the respective Deputy Secretary General of the region and supported by FAOPS with USD2,500
