By-Law VIII Congress

1. Member societies of the Federation can bid to hold the congress. 2. Bidding process for the congress shall entail the following process: a. Expression of interest should be received in writing to the council at least 3 months before the congress preceding the target year by three congresses (i.e. 3 years ahead of target schedule) b. Bidding and decision on congress venue shall be held and announced 3 years in advance or 3 congresses ahead of schedule, c. FAOPS President confirms in writing to the winning country, the privilege to hold the congress. d. A signed memorandum of understanding between the FAOPS and the country perinatal society president shall be undertaken and duly signed by both parties. e. The congress organization and management shall be solely the responsibility of the local perinatal society.
