Scope op presentation and paper:

- 1. The academic value of the book "compendium of materia medica" and it's influence on later generations, it's circulated version and the anecdotes of the life of the author, Li Shizhen, and other related historical research.
- 2. Herbal philology and pharmacy character study: including all previous dynasties herbal philology and their author's research.

- 3. Variety herbalogical study: including textual research of Chinese traditional medicine and ethnic drug varieties.
- 4. Medicinal theory and processing evolution, textual research about clinical application.
- 5. Medicine history study, including:
 - (1) History of ancient Chinese medicine;
 - (2) the history of modern medicine, especially the introduction of western medicine and their development history in China;
 - (3) History of Chinese-foreign drugs' exchange;
 - (4) History of famous medicinal factory and store, high quality Traditional Chinese Medicine Patent Prescription, local history of pharmaceutical affairs, druggist development, medicinal herbs distribution history, history of medicine institutions, pharmaceutical education, single herb medicine history;
 - (5) medical related folklore study.
- 6. Study of the ethnic medical history, the focus is on ethnic medicine history materials, ancient documents and historical drug characteristics, classical and folk TCM prescription sorting-out research.

Paper requirements:

Paper should have the innovative ideas and reliable citing data. It is generally within 3000 words, with summary within 400 words except advanced arrangement contribution. Request Word document in principle, manuscript should be clean and tidy if can't provide electronic documents. Once the Dissertation is selected, we will compile and print the colloquium papers.

二、征文范围:

- 1.《本草纲目》的学术价值、对后世的影响、流传的版本以及作者李时珍的生平、轶事等相关史学研究。
- 2. 本草文献学及药学人物研究:包括对各个时期的历代本草文献及其作者的研究。
 - 3. 药物品种的本草考证研究: 包括中药及各民族用药品种的考证。
 - 4. 药性理论、炮制沿革、临床应用的本草考证研究。
- 5. 药学史研究:包括①古代药学史;②近代药学史(特别是西药的传入及在 国内的发展历史);③中外药物交流史;④药材生产经营厂店史与名优成药史、 地方药事史、药商发展史、药材集散史、药学机构史、药学教育史、单味药药学 史;⑤与医药有关的民俗研究。
- 6. 民族医药学史研究,重点是民族医药的史料、古籍文献、用药特点、经典方与民间常用方的整理研究。
- 三、论文要求:论文立意要有创新性,引证资料可靠。字数除特约稿外,一般在3000字以内,并附400字以内的摘要。原则上要求投送电子Word文档,个别无条件者也可投送手写稿。但要求字迹工整清楚。论文入选后,将统一编印论文集。
 - 四、论文截止日期: 2013年8月31日。
